



3rd Annual Shrimpfest Fishing Tournament

Seadrift Bayfront

June 16th, 2018

Registration check-in Friday June 15th, 2018 at 4-6pm with Mandatory Captain's meeting to follow.

Tournament will be held Saturday June 16th, 2018- First Cast TBD at captains meeting.

Weigh-In will be held at the fishing tournament tent from 2-4pm. Tent will be located at the **West end of the Seadrift Bayfront Pavilion.**

Weightmaster must have your weigh-in tag by 4pm sharp at the shuttle pickup location. No exceptions!

Mandatory Tournament Entry:

Combined Stringer- 3 Trout (none over 25"), 1 slot redfish - \$350 entry fee

OPTIONAL Side pots:

Combined Stringer Calcutta- \$150

Big Red-\$50

Big Trout- \$50

Redfish Spot Pot- \$50

Tournament Prizes:

Combined Heaviest Stringer: Based on a 40 boat field @ \$350 a team*.

Official Rules:

1) Team Entry fee of \$350 must be received by June 1st in order to receive your tournament t-shirt. Entries after June 1st will not be guaranteed a shirt. If registering online, side pots to be paid at Friday night check-in.

2) Tournament Teams will consist of 1-4 people. Only one team per boat and everyone in boat is a team member.

3) Boundaries- Boundaries are from the Colorado River to Ayres Dugout. First Cast will be announced at captains meeting.

4) Launch- You may launch anywhere.

5) No sharing or pooling of fish with other teams and boats is allowed.

6) All anglers must carry a valid Texas fishing license with a saltwater stamp. All federal, state and tournament rules will be abided by including valid fishing license.

7) Live, dead or artificial bait is allowed

8) Combined stringer will consist of 1 slot redfish and 3 trout. No tagged redfish over 28" will be allowed. No trout over 25" per team will be allowed including the side big trout pot. All fish will be allowed to be weighted in one time only and not used in multiple categories.

9) Weigh master will have final say on eligibility on any fish brought to the scales. No pale, gilled, or mutilated fish will be allowed. Team will be disqualified. A trimmed tail is a mutilated fish. In the event of a tie in weight, the first team to weigh in will be winner.

10) Minimum of one person per team must attend the mandatory captains meeting.

11) In the event of inclement weather, the tournament will be rescheduled. Decision on weather to be made by the tournament officials and notifications will be placed by phone calls or email to team captains.

12) Teams may launch at any boat ramp and return to the Bayfront fishing tournament shuttle location by 4pm for weigh-in. You may not carry any extra gas in boat other than in the factory installed oem gas tank.

13) Weigh-in time is Saturday from 2pm-4pm. At least one team member must present the weighmaster with your weigh-in tag and be standing in line at the shuttle pickup location with your fish by 4pm sharp. NO EXCEPTIONS. There will be no sorting or culling of fish once your team is in line with fish for weigh-in.

14) The official clock will be "cellular phone" time and will be monitored by the weigh-in team.

15) Teams must fish in public waters accessible to public fisherman.

16) Any protest must be filed orally or in writing with the tournament director by the end of the weigh-in.

17) 50 yd rule between tournament boats and fisherman, unless waived in will apply. Passing on plane, within 50 yds of a wading fisherman is strictly prohibited.

18) Teams will not be allowed to hold another boats fishing spot for any reason.

19) Wade fisherman must remain within plain eyesight of their fishing partners and boat at all times.

20) Any boat that becomes disabled during the tournament may be towed back to weigh-in. Anglers may NOT transfer fish to another boat to be transferred to weigh-in.

21) All fish must be caught by rod and reel in adherence to State Law on the day of the tournament.

22) If you hook a fish, that fish is yours and yours only to fight. You may not pass the rod to another team member to fight fish. Wade fisherman must net their own fish. Boat fisherman may have another team member that is also inside the boat net their fish.

23) Awards and raffle items will be given out at the Fishing Tournament Tent following the weigh-in.

24) These rules are subject to change prior to tournament day. All final rules will be gone over at mandatory captains meeting Friday evening.

25) This is an open fishing tournament. Guides will be allowed.

26) Every angler receiving a tournament prize is subject to a polygraph test. Results of polygraph test are final. Any person caught cheating will be disqualified and charges will be pressed.

27) Polygraphs--- By signature on the official tournament entry form, each contestant agrees to submit to a polygraph test and abide by its conclusion. A mandatory polygraph test will be administered to one team member on the winning team of the combined stringer selected by the tournament directors. No money will be paid out until polygraph test is completed and passed. The results of the polygraph test are final and cannot be reviewed by a court of law.
